Introduction to ZEON Chemicals Europe Ltd.

The ZEON Chemicals Europe Ltd. (ZCEL) facility at Barry, Wales, UK, has been in operation since the late 1950's. From 1967 until 1989, the plant was under the control of BP Chemicals Ltd., and in 1989, ZEON Corporation took over the operation.

NBR, ZSC and NBR-Lx are produced at this plant and exported to Europe, America and Asia.The plant is also the location of the European Technical Service Laboratory. ZCEL has 89 employees and its production operation has management systems that are registered as compliant with both ISO 9001 and ISO 14001 standards.

ZCEL operates from a single site, situated in the center of the Barry Industrial Complex, which also houses AES, Momentive Chemicals, Cabot Carbon, Dow Corning, National Power, and Vopak Tank Terminal. The complex is situated within the Vale of Glamorgan approximately two kilometers east of Barry's town center.

1. Reducing Waste

Waste reduction has always been a key objective as part of continual improvement in environmental and overall business performance.

There was an objective in 2011 to reduce overall waste to landfill to comply with the new legislation and waste hierarchy requirements. Also to reduce costs of waste disposal which are increasing substantially year on year. A new outlet for our hazardous waste was found after it had been allowed to weather to reduce its monomer content as a low quality material for processing in Asia. This material has been renamed Z grade and will continue to be sold in 2012.
