Environmental and Safety Activities

1. Efforts to Reduce Environmental Impact

As a means to reduce our emissions of substances subject to the PRTR Law, we continue making efforts to minimize our usage volume of ethylene oxide by reducing the operating number of our sterilization machines, of which we currently have four, to the minimum required by production conditions. Although we have not yet achieved a reduction in our total usage of ethylene oxide, we are maintaining usage volume with respect to production increases.

Regarding the reduction of electricity usage, we continue to engage in steadfast energy-saving initiatives, including managed temperature settings and the elimination of unneeded lighting. However, with our use of clean rooms enhancing the impact of weather and with increased electricity usage under increased production also a factor, the effects of our energy-saving initiatives were not marked.
