ZEON Corporation (2-6-1 Marunouchi, Chiyoda-ku, Tokyo; President & CEO: Katsuhiko Nakano; hereafter ZEON) and Fujitsu Social Science Laboratory Limited (1-403 Kosugi, Nakahara-ku, Kawasaki, Kanagawa; President: Kiyoshi Saito; hereafter Fujitsu SSL) have announced the establishment of Anthos Information Systems Co., Ltd., as a joint venture, effective April 1, 2003. The new company is a spin-off of the software services sales division of ZEONâ€<sup>™</sup>s wholly owned subsidiary ZEON Information System Co., Ltd. (President: Masanobu Inoue; hereafter ZEON Information System).

ZEON Information System is positioned as a specialized company for information systems of ZEON Corporation that primarily produces chemical materials including synthetic rubbers, chemical compounds, and specialty plastics. The company demonstrates a high level of expertise in POP\* and CRM\* systems for improving efficiency based on production sites demand, and it possesses a wealth of experience in constructing systems related to material production.
